## **Bins On Silvery Sands**

We have all bin watching as the council and environment agency squabble over who should empty the two bins on Silver Sands. Currently we have the environmental heath putting pressure on the EA and Michele is trying to work wonders with the council to find the funds.

In the past we have emptied the bins on occasion to keep the neighbourhood clean and tidy. However, at the moment we are not doing this in order to keep the pressure on via environmental health.

We hope the situation is sorted soon. However, we still have a few aces up our sleeve. So please be patient.

## **Swans**

Over the years we have always had a presence of swans which have come over from Truss Island to be fed or to graze on the bank or meadow which has never been a problem. Over the last 18 months or so the numbers of swans in our area has increased dramatically. We now get flocks of 100+ birds on the bank which deposit a considerable amount of guano. This overflow from Truss Island has started to cause environmental health issues for local residents on our side of the river due to the amount of droppings including:-

- > Asthma from the ammonia.
- Blue bottle flies.
- Rats

The problem appears to be caused by the re-homing of swans by the Swan Sanctuary to Truss island and the large scale illegal dumping of commercial food waste which contributes a considerable share of the over feeding. The swans are better off eating their natural food such as weed and grass which are both in plentiful supply. We are trying to reduce the illegal feeding and hence encourage them to disperse. We are not trying to discourage the legal activities of families with a few slices of bread.

# **Rogue Boat**

We get the occasional boats mooring along the public footpath. However, they are only supposed to stay for up to 24 hours. Some stay a little longer. We have one boat outside 84 Thames Side that has outstayed it's welcome. The EA have been contacted and they are actively trying to get the boat to move on. Thanks to all those people who have contacted the EA to in support with this issue.
